Contractual Information

Section 15.5 Unit members may elect to maintain District insurance through August 31 if a written notice of intent to retire (following completion of continued employment up to the last contract day of the same contract school year) is submitted to the Board office by **March 15**. The written notice of intent to retire must include a statement indicating whether the unit member wishes to continue their District insurance through August 31. If not, the District insurance will be terminated on May 31.



LPDC - Renewing your license? Remember to write a new IPDP.

Renewing early? Important info: new CEUs can't be earned until after July 1, when new license starts. So if you get a new IPDP written and approved in March but new license doesn't start until July 1, then no CEUs will count until after the start date of new license (July 1). If taking college courses, be sure they end after July 1 so the CEUs will count toward your new license.
