

A master teacher strives for distinguished teaching and continued professional growth as specified by the Ohio Standards for the Teaching Profession. Master Teachers are eligible to advance from a Professional Educator License to a Senior Professional License. Master teacher designation is for five years and is renewable.

Teachers seeking to be named Master Teachers must have taught for a minimum of seven years. Candidates submit written responses and evidence samples of consistent leadership, focused collaboration, distinguished teaching and continued professional growth along with professional recommendations. The submissions are scored by a district level committee of teachers and administrators using the Ohio Master Teacher.

An informational meeting for Westerville teachers interested in earning Master Teacher designation was held on November 12. You can view the presentation on the intranet. If you were unable to attend or have additional questions contact Lisa Kuhar. Applications for Master Teacher must be submitted to the Human Resources office at the Early Learning Center by April 30, 2015.
