October is open enrollment month for our medical insurance. **EVERYONE** using Westerville's Health Plan <u>must</u> fill out the HSA funding election form 2015, sent to you via e-mail from the treasurer's office. The deductibles have gone up per IRS, \$1300 for single and \$2600 for family. Your form needs turned into the Treasurers' office *****Due by November 7****

A **Flexible Spending Account** (FSA) is another way to use pre-tax dollars to help with medical related expenses. If you want the government to pay for a part of your braces, glasses or other related expenses not fully covered by our insurance, sign up for an FSA. If you plan on retiring this school year, don't put money into a FSA instead put that additional money into your HSA. That way the money can be spent after you leave the system.

If retiring this school year, you should also make your contributions to your HSA either as a one time payment or over 12 consecutive pay periods. Do not make your contributions over the 24 consecutive pay periods because you will have already left the system.
